1. Experience Requirements

shall provide the requested references for clients who have obtained construction services similar to those required for the Project from the Supplier in the last ten **(10)** years. Failure to provide verifiable experience shall result in the bid being declared non-compliant.

3. Qualification Requirements

Each Supplier shall acquire and upload a copy of a valid Certificate of Recognition (COR[™]) or Equivalent OHS Certification, such as ISO 45001 in the legal name of the Supplier or in the case of a joint Bid, for, and in the name of, each member of the Joint Bid Team.
