EXECUTIVE SUMMARY

City of Toronto (Client) retained Pinchin Ltd. (Pinchin) to conduct a hazardous building materials assessment at Seven Oaks Long Term Care Home located at 9 Neilson Road, Scarborough, Ontario. Pinchin performed the assessment on August 25, 2022.

September 19, 2022

Pinchin File: 314479.000

The objective of the assessment was to identify specified hazardous building materials in preparation for an upcoming handrails replacement project. The proposed work as identified by the Client includes removal of existing handrails present within select locations and will likely disturb existing wall finishes within the project areas. These areas are defined in the drawing provided by the Client entitled "Seven Oaks Handrail Replacement, dated July 28, 2022", prepared by Montgomery Sisam Architects Inc. (Job No. 21509.F02).

The assessed area is limited to the railings on the 1st and 2nd floor, as shown on the drawings in Appendix I.

SUMMARY OF FINDINGS

The following is a summary of significant findings; refer to the body of the report for detailed findings:

Asbestos:

No asbestos-containing materials were identified

Lead:

- Sampled paints contain an insignificant level of lead (<0.009%).
- Lead may be present within batteries of emergency lights.

Silica: Crystalline silica is present in concrete, mortar, masonry, ceramics, grout, drywall, and ceiling tiles.

Mercury: Mercury vapour is present in lamp tubes.

Polychlorinated Biphenyls (PCBs): PCBs are not present within the assessed area.

Mould and Water Damage: Visible mould and water damage was not observed during the assessment.

1.0 INTRODUCTION AND SCOPE

City of Toronto (Client) retained Pinchin Ltd. (Pinchin) to conduct a hazardous building materials assessment at Seven Oaks Long Term Care Home located at 9 Neilson Road, Scarborough, Ontario.

September 19, 2022

Pinchin File: 314479.000

Pinchin performed the assessment on August 25, 2022. The surveyor was unaccompanied during the assessment. The assessed area was occupied at the time of the assessment.

The objective of the assessment was to identify specified hazardous building materials in preparation for a handrail replacement project. The proposed work includes removal of existing handrails present within select locations and will likely disturb existing wall finishes within the project areas defined in the drawing provided by the Client via email on August 9, 2022, entitled "Seven Oaks Handrail Replacement, dated July 28, 2022", prepared by Montgomery Sisam Architects Inc. (Job No. 21509.F02).

1.1 **Scope of Assessment**

The assessed area is limited to portions of the 1st and 2nd floors, as described by the Client, and identified in the drawings in Appendix I.

The assessment was performed to establish the type of specified hazardous building materials, locations and approximate quantities incorporated in the structure and its finishes.

For the purpose of the assessment and this report, hazardous building materials are defined as follows:

- Asbestos
- Lead
- Silica
- Mercury
- Polychlorinated Biphenyls (PCBs)
- Mould

The following Designated Substances are not typically found in building materials in a composition/state that is hazardous and were not included in this assessment:

- Arsenic
- Acrylonitrile
- Benzene
- Coke oven emissions
- Ethylene oxide
- Isocyanates
- Vinyl chloride monomer

2.0 METHODOLOGY

Pinchin conducted a room-by-room assessment (rooms and corridors) to identify the hazardous building materials as defined in the scope.

September 19, 2022

The assessment was limited to building wall finishes to be affected by the planned renovations. Areas above ceiling systems or behind wall systems will be not impacted, as confirmed by the Client, by the scope of the handrail replacement project, and were therefore not assessed.

The assessment did not include limited demolition of wall and ceiling finishes (drywall or plaster) to view concealed conditions at representative areas as permitted by the current building use. Limited destructive testing of wall finishes was conducted where possible (drywall, masonry walls). Demolition of exterior building finishes, masonry walls (chases, shafts etc.), and structural surrounds was not conducted.

For further details on the methodology including test methods, refer to Appendix III.

4.0 FINDINGS

The following section summarizes the findings of the assessment and provides a general description of the hazardous materials identified and their locations. For details on approximate quantities, condition, friability, accessibility, and locations of hazardous materials; refer to the survey forms (room-by-room) in Appendices IV.

Any quantities listed in this report or survey forms (room-by-room) are estimated based on visual approximations only and are subject to variation.

4.1 Asbestos

4.1.1 Acoustic Ceiling Tiles

Acoustic ceiling tiles do not contain asbestos as previously confirmed in the report prepared by Fisher (Project No. FE-P 21-11263). Acoustic ceiling tiles will not be impacted by the scope of the handrail replacement project.

4.1.2 Drywall Joint Compound

Drywall joint compound present on wall and ceiling finishes throughout Locations 1-089, 1-092, 1-051, 1-058, 2-019, 2-045, 2-071 does not contain asbestos (samples S0002A-C, S0003A-E, S0004A-G).

- Concealed adhesives and duct mastics
- Caulking and putties
- Fire resistant doors
- Sealants on pipe threads

4.2 Lead

4.2.1 Paints and Surface Coatings

Refer to the lab report in Appendix II-B and the Hazardous Materials Summary Report in Appendix V for details on paints sampled and their locations.

The following table summarizes the analytical results of paints sampled.

All paints sampled were below 0.009% (90 mg/kg). Paints containing less than 0.009% (90 mg/kg) lead is assumed to be insignificant.

4.2.2 Lead Products and Applications

Lead-containing batteries may be present in emergency lighting.

Crystalline silica is known to be a component of the following materials:

- Poured or pre-cast concrete
- Masonry and mortar
- Ceramic tiles and grout
- Drywall
- Ceiling tiles

4.4 Mercury

4.4.1 Lamps

Mercury vapour is present in fluorescent lamp tubes.

4.4.2 Mercury-Containing Devices

Mercury-containing devices were not found during the assessment.

4.5 Polychlorinated Biphenyls

4.5.1 Lighting Ballasts

Based on visual observations (evidence of T-5 with magnetic ballasts) the assessed area will not contain PCB ballasts.

4.5.2 Transformers

Transformers were not found during the assessment.

4.6 Mould and Water Damage

Visible mould growth and water damage was not found during the assessment.

5.0 RECOMMENDATIONS

5.1 General

- 1. If suspected hazardous building materials are discovered during the planned work, which are not identified in this report, do not disturb, and arrange for further testing and evaluation.
- 2. Provide this report to the contractor prior to bidding or commencing work.

5.2 Building Renovation Work

The following recommendations are made regarding renovation involving the hazardous materials identified.

5.2.1 Lead

Exposure from construction disturbance of paints containing lead less than 0.009% (90 mg/kg) is assumed to be insignificant.

Lead-containing items should be recycled when taken out of service.

5.2.2 Silica

Construction disturbance of silica-containing products may result in excessive exposures to airborne silica, especially if performed indoors and dry. Cutting, grinding, drilling or demolition of materials containing silica should be completed only with proper respiratory protection and other worker safety precautions that comply with per applicable regulations and guidelines.

5.2.3 Mercury

Do not break lamps. Recycle and reclaim mercury from fluorescent lamps when taken out of service. Mercury is classified as a hazardous waste and must be disposed of in accordance with applicable regulations.





APPENDIX III
Methodology

1.0 GENERAL

An inspection was conducted to identify the type of Hazardous Building Materials incorporated in the structure and its finishes.

Information regarding the location and condition of hazardous building materials encountered and visually estimated quantities were recorded. The locations of any samples collected were recorded on small-scale plans. As-built drawings and previous reports were referenced where provided.

Sample collection was conducted in accordance with our Standard Operating Procedures.

1.1 Asbestos

The inspection for asbestos included friable and non-friable asbestos-containing materials (ACM). A friable material is a material that when dry can be crumbled, pulverized, or powdered by hand pressure.

A separate set of samples was collected of each type of homogenous material suspected to contain asbestos. A homogenous material is defined by the US EPA as material that is uniform in texture and appearance, was installed at one time, and is unlikely to consist of more than one type or formulation of material. The homogeneous materials were determined by visual examination and available information on the phases of construction and prior renovations.

Samples were collected at a rate that is in compliance with the requirements of local regulations and guidelines. The sampling strategy was also based on known ban dates and phase out dates of the use of asbestos; sampling of certain building materials is not conducted after specific construction dates. In addition, to be conservative, several years past these dates are added to account for some uncertainty in the exact start / finish date of construction and associated usage of ACM. In some cases, manufactured products such as asbestos cement pipe were visually identified without sample confirmation.

The asbestos analysis was completed using a stop-positive approach. Only one result meeting the regulated criteria was required to determine that a material is asbestos-containing, but all samples must be analyzed to conclusively determine that a material is non-asbestos. The laboratory stopped analyzing samples from a homogeneous material once a result equal to or greater than the regulated criteria is detected in any of the samples of that material. All samples of a homogeneous material were analyzed if no asbestos is detected. In some cases, all samples were analyzed in the sample set regardless of result.

The analysis was performed in accordance with Test Method EPA/600/R-93/116: Method for the Determination of Asbestos in Bulk Building Materials, July 1993.

Where building materials are described in the report as "non-asbestos" or "does not contain asbestos", this means that either no asbestos was detected by the analytical method utilized in any of the multiple samples or, if detected, it is below the lower limit of an asbestos-containing material in the applicable regulation. Additionally, these terms are used for materials which historically are known to not include asbestos in their manufacturing.

1.2 Lead

Samples of distinctive paint finishes, and surface coatings present in more than a limited application, where removal of the paint is possible was collected. The samples were collected by scraping the painted finish to include base and covering applications.

Analysis for lead in paints or surface coatings was performed in accordance with EPA Method No. 3050B/Method No. 7420; flame atomic absorption.

1.3 Silica

Building materials known to contain crystalline silica (e.g. concrete, cement, tile, brick, masonry, mortar) were identified by visual inspection only. Pinchin did not perform sampling of these materials for laboratory analysis of crystalline silica content.

1.4 Mercury

Building materials, products, or equipment (e.g. thermostats, barometers, pressure gauges, lamp tubes), suspected to contain mercury was identified by visually inspection only. Dismantling of equipment suspected of containing mercury was not performed. Sampling of these materials for laboratory analysis of mercury content was not performed.

1.5 Polychlorinated Biphenyls

The potential for light ballast and oil filled transformers to contain PCBs was based on the age of the building, a review of maintenance records and examination of labels or nameplates on equipment, where present and accessible. The information was compared to known ban dates of PCBs and Environment Canada publications.

1.6 Visible Mould

The presence of mould or water damage was determined by visual inspection of exposed building surfaces. If any mould growth or water damage was concealed within building cavities it was not addressed in this assessment.
