The following additional instructions and/or amendments shall apply to and govern the bid documents:

ARCHITECTURAL

1. Question: Documents indicate the project may commence January 9, 2023. Confirm rooms 107, 109, 111, 113 will have contents removed and remain vacant from this date forward?

Answer: All loose items not shown in the Tender Documents will be removed by the SCDSB prior to the construction start date.

2. Question: Will exterior works be permitted during the school day following satisfactory installation of construction/safety fencing?

Answer: Refer to Specification Section 01 01 00 item 5.7 that describes the work during school hours. As mentioned on site, any demolition work or work that involves high level of noise cannot be permitted during the school hours. It must be done after hours.

3. Question: Dwg. A2.1 indicates screen to be removed at lobby 100 but dwg. A2.2 indicates it is to remain. Which is it?

Answer: Hollow metal screen to remain. Delete note on drawing A-2.1 "EX. SCREEN TO BE REMOVED". Partition type P3 to be built on Lobby side of hollow metal screen.

4. Question: The new canopy is to be clad in steel siding and same is to match existing. Kindly advise the profile and a source for this siding as it is not recognized. Otherwise kindly advise that an alternate profile and colour, as may later be agreed upon by the Consultant, will be acceptable.

Answer: Refer to specification section 07 42 00 Preformed Metal Siding for information regarding steel siding, soffit and trim.

5. Question: The control panels are shown on the drawings as being manufactured by the Millwork supplier and there is also a specification to have them supplied through Interspec. Please confirm which we should include in our bid.

Answer: Control panel to be as per specification section 10 15 00, Classmate as manufactured by Interspec Systems Ltd., 705-435-3780 <u>WWW.interspecsystems.com</u>. Delete details 1-A6 and 2-A6 on drawing A-6.

6. Question: Some of the timber is hard to find PT – are we able to use cedar in lieu?

Answer: Where dimensions of lumber specified is not available as pressure treated lumber, other species of wood will

be acceptable.

7. Clarification: See hoarding location on plan attached, the location of hoarding will be as per the attached plan until the exterior work is started. When exterior work to start hoarding to be reconfigured to match hoarding location shown on drawing 2-A1. Attachment: Site Plan-Revised Hoarding Area.


