The following modifications and clarifications shall be taken into consideration when tendering on the aforementioned Contract, and when entering into the Form of Agreement to do the Work, they shall become a part thereof.

ITEM #1: CLARIFICATIONS

1. As part of the base bid, provide for (45.0 sq. m.) of substrate repairs as required to complete scope of work noted for Roof #4. Repairs to be full metal panels, spanning the 8' to 10' steel trusses (as existing), metal deck profile and gauge to match existing (1 ½" deep steel deck fastened to 8" deep W-section purlins spaced at 8'-4" O/C).
2. Revise Item #1 of Alternate (Separate) Prices to include for (20 sq. m.) of substrate repairs to the wood deck. Repairs to wood deck to be 1" Sheathing or framing (to match existing – 1" sheathing on 2"x12" wood joists @ 20" O/C on 18"x24" select Structural solid douglas fir beams @ 18' O/C).
3. Add Item # 2 to the list of Alternate (Separate) Prices to include for a lump sum price for all work according to the requirements of the drawings and the specifications to complete the scope associated with the second half (or remainder) of roof #4 (additional area 1,227.5 sq.m.). Price to include for (45 sq.m.) of substrate repairs to the metal deck. Repairs to be full metal panels, spanning the 8' to 10' steel trusses (as existing), metal deck profile and gauge to match existing (1 ½" deep steel deck fastened to 8" deep W-section purlins spaced at 8'-4" O/C).
