## SCHEDULE A SCOPE OF WORK

## I. <u>Background</u>

Seneca's Newnham Campus, located at 1750 Finch Avenue East in Toronto, Ontario. This RFS is an invitation to submit a proposal for the renovation of the existing area in Building K known as FASET Faculty Offices.

The FASET Faculty Area K3170 will be renovated into the Engineering and Digitalization lab. This newly renovated space will be required to support Seneca's engineering degree programs. The space will be divided into four areas: an Open Engineering space, Makerspace, Capstone rooms and a meeting room.

The open engineering space has a workstation requirement of approximately 40 students. The space will consist of a Digitalization computer lab, a high-end computer lab with machines capable of handling demanding digital design programs.

The Capstone rooms shall be used by teams to work on their projects. A "Makerspace" where engineering students can work on projects that require specialized tools such as hacksaw, drill press and 3D printer. The meeting room shall be used for industry partners and presentations.

## II. Specific Description of Work

The Proponent shall refer and comply with the complete set of specifications and drawings as noted in this Scope of Work and all Appendices provided herewith for specific contractual requirements. The current area consists of approximately 3000 square feet and shall be expanded by an additional 500 square feet. Meeting room, open hotel desk area, kitchenette and five smaller meeting rooms.

Seneca's objectives are to renovate the existing faculty offices known as FASET into an engineering lab.

The renovations will include but are not limited to;

- a. Demolition,
- b. New partitions,
- c. Millwork,
- d. Floor and wall finish,
- e. Ceiling works,
- f. Mechanical works,
- g. Electrical works and,
- h. Acoustics work,
- i. AV scope, GC to tender the AV drawing package to Seneca approved vendors. This tender is included in the overall tender of the project. It shall be the responsibility of the GC to manage the AV trades in the overall schedule.
- j. Furniture the GC will be responsible for managing the delivery and installation of all the furniture vendor Seneca has ordered furniture from.
- k. Network scope shall be completed by Seneca vendor Telecom by Design, it is the GC responsibility to ensure the cost of the scope and time management of the scope is met with rigor to meet the schedule.
- I. Security camera scope shall be completed by Seneca vendor 3 D Technology, it is the GC responsibility to ensure the cost of the scope and time management of the scope is met with rigor to meet the schedule.

- m. Card Reader scope shall be completed by Seneca vendor Paladin, it is the GC responsibility to ensure the cost of the scope and time management of the scope is met with rigor to meet the schedule.
- n. The GC shall be responsible for closing out the permit in the city of North York.
