Q2 : Please provide the name of the manufacturer of Panel A.

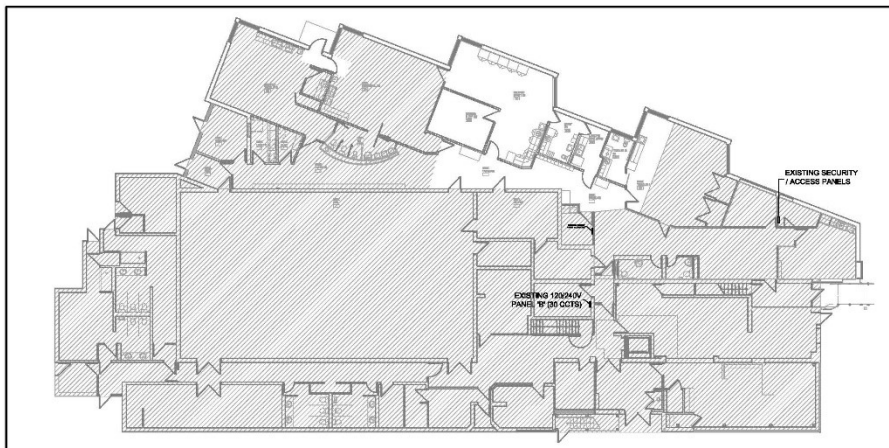
A2 : No manufacturer name on panel 'A'. Find attached photos of panel 'A'.

3.0 THERMOGRAPHIC INVESTIGATION

3.1 Check and inspect existing distribution equipment to be re-used (i.e., panels, panel breakers, disconnect switches, etc.) for any evidence of abnormal overheating conditions. Report to Consultant and rectify any issues encountered. Perform thermographic scan under actual tenant load in operations and submit scan results indicating problems have been corrected to Property Management for review and include same in Maintenance Manuals.
