1. Experience Requirements

The Supplier must have the following experience in order to be considered for award of the Contract:

- The General Contractor who submits the bid for this Tender Call shall carry:
 - An Electrical Contractor as subcontractor for fire alarm / electrical work
 - An experienced Distributed Antenna System installer (See the Scope of Work for contact information for DAS vendor)
 - o A Mechanical Contractor as subcontractor for mechanical/HVAC work and
 - A General Trades Contractor as a sub-contractor for all demolition, architectural and minor structural work.
 - All employees assigned to the project must be eligible to obtain security clearance from Toronto Police Service.

As most of the work is Fire Alarm/Electrical, it is preferable that the General Contractor be an Electrical contractor.

Fire Alarm / Electrical Work:

The contractor performing Fire alarm/Electrical work must have the following experience and qualifications to be considered for award:

- Must possess a valid Electrical Contractor License, issued by the Electrical Safety Authority (ESA) of Ontario, prior to award and for the duration of the Contract. Must provide the City with a copy of their valid ESA Electrical Contractor Licenses with bid submission.
- Must be Canadian Fire Alarm Association (CFAA) certified and in good standing.
- Must possess a minimum of five (5) years experience with the installation of VITALink cables.

Mechanical Work:

The sub-contractor performing mechanical work must have the following qualifications to be considered for award:

 Must possess a valid TSSA Contractor License for Mechanical work, issued by the Technical Standards and Safety Authority (TSSA) for the duration of the Contract. Must provide the City with a copy of their valid TSSA Mechanical Contractor Licenses with bid submission.

2. Project Experience / Comparable Projects

The Supplier must provide reference projects for the purpose of confirming the Supplier's experience and track record of success. The Supplier shall provide the requested references for clients who have obtained construction services similar to those required for the Project from the Supplier in the last seven (7) years. Failure to provide verifiable experience shall result in the bid being declared non-compliant.

The Supplier shall provide **three (3) project references** with similar scope of work for the past seven (7) years, related to the following:

- Completion of a large-scale Fire Alarm system installation in a mission-critical facility or high-rise fully occupied government buildings.
- Electrical Upgrades, especially on life safety and/or critical services such as Fire alarm replacement, UPS or generator power.
- At least one project related to completion of a Distributed Antenna System (DAS) as part of the Emergency services to enhance emergency responders (eg. Fire fighters, law enforcements..) radio communications.

Each projects' values should be in the range of <u>more</u> than one million dollars (CAD\$1,000,000.00)

3. Qualification Requirements

a. Current Certificate of Recognition (COR®) or equivalent OHS Certification

Each Supplier shall acquire and upload a copy of a valid Certificate of Recognition (COR[®]) or Equivalent OHS Certification in the legal name of the Supplier or in the case of a joint Bid, for, and in the name of, each member of the Joint Bid Team.
