2. Questions and Answers:

Q1: Refer: AV601. The drawing indicates that each paging horn/speaker within the dome (playing field) to be connected to an

independent channel of amplification. This appears unusual approach for this space. Typically loudspeakers would be grouped into circuits dependent on wattage loading and available power amplification.

Since the dome area is one open space (one zone) please provide clarity on the need for each horn speaker circuited back to the power amplifier. To greatly save cost of equipment and labour will CoB accept that the Dome area be considered a single PA Zone with 2 groups of PA Horn circuits (5 horns x 2 circuits).
