- 2. One (1) of the three (3) projects must include the installation of an Air Supported Structure (dome) component.
- 3. Projects including an Air Supported Fabric Structure, permanent structures (building), concrete skateboard parks, sports fields and sports field lighting will be looked upon more favorably.
- 4. Project examples must clearly demonstrate similarities to complexity, size and scope as described in this RFP.
- 5. Bidders are to include, with their submissions, Project Sheets, for all projects listed, that identify all relative information demonstrating similar scope as described in this RFP.
- Projects sheets are to be clearly referenced to the Projects listed in Table 1.2.2 Project Experience. Include a proposed schedule specifically for the proposed Cassie Campbell project.
- 7. Project examples can be completed by either the Contractor or the Sub-Contractor – upload project examples in Attachment G.
