## 4. BIDDER QUESTIONS AND CITY RESPONSES

Q5: Could you please clarify that what is the difference between the 14 and 18 codes under T8 LED LIGHTING RETROFIT TYPES (Section 26500 on Page#32). It looks to possibly be a TYPO where the 14 is 4ft and 18 is 8ft. But by the current description it is the same? Please advise.

R5: The '18 Codes' describe an 8' long fixture with 4' long lamps in tandem or 'end-to-end' arrangement. There are no 8' long lamps on the project.

Q6: Can I get a two week extension on this bid? My suppliers are having a difficult time pulling the lighting pricing together.
