Question 2: on the site meeting it was mentioned that the removal of asbestos will be carried by the school board. Please confirm if this scope of work will be done by school board or is asbestos removal will be under cash allowance. if it is to be under cash allowances, please indicate the amount of cash allowance for this scope of work.

Answer 2: The asbestos removal will be carried out by the Board's prequalified environmental contractor. It is not under any cash allowances.

Question 3: Please confirm that the plumbing fixtures mentioned under Plumbing Specification table, on drawing A1.01 is not under cash allowances and to be part of this contract.
