#### Question 1:

Please confirm if DDSB has an approved list of abatement contractors

**Answer 1:** An approved list of abatement contractors is provided in Section 13.1, titled "Abatement Contractors," of the tender documents.

# Question 2:

Please consider adding Crozier Environmental to the list of abatement contractors

**Answer 2:** The DDSB approves the addition of Crozier Environmental to the list of approved abatement contractors for this project.

### Question 3:

We would like to request an extension for the closing date

**Answer 3:** No extension will be granted, and the closing date remains as specified in the tender documents.

### Question 4:

There is a note on the drawing R500 that there are some new light fixtures to be installed by electrician and supplied by the owner, please advise which are new and how many?

### Answer 4:

All light fixtures indicated or referenced on drawing R201, R500, and R502 are to be replaced with new and shall be supplied by the owner. The new light fixtures will be typical 2'x4' troffer lights inset into the T-bar system. The number of new light fixtures to be installed shall match the quantity of existing light fixtures being removed. The cost for the installation of these new light fixtures shall be included in the stipulated bid price, and no cash allowance will be used to facilitate their installation.

It should be noted that cleaning of all fixtures/equipment on the ceiling as part of abatement is to be included as part of base bid (i.e. cleaning/abatement is required before disconnection). For ceiling tiles with smoke/heat detectors, the bidder is to coordinate cleaning and protection as required (reverification of smoke detectors is not required, provided the existing ceiling tile can be maintained/protected. If maintained, the existing ceiling tile can be reused as part of new ceiling tile system).

#### Question 5:

Please provide list of prequalified electrical contractors or can any electrician price this tender?

The separate price room numbers 111B and 1137 are not matching up with the drawings. I'm assuming you meant to write room number 112B and Stairwell 137? Please confirm.

The alternate price room number 11B is not matching up with the drawings. I'm assuming you meant to write room number 112B? Please confirm

## Question 7:

Can you please share the electrical drawings that can help us understand the scope and price it based on that. Or else, can we give a cash allowance for electrical work.
