QUESTIONS & ANSWERS

QUESTION 1: Flooring clarifications:

- a. Floor tile is spec'd as 12x24, but rooms are 5x6. please confirm this is intention?
- b. Existing terrazzo at corridor and new ceramic tile may cause a height issue. please confirm if flooring infill required?
- c. Wall tile CWT 4x16 is to be installed down to floor, however specs indicate a 4x12 cove base. The specified floor tile does not come in a cove base option. Please confirm.
- Specifications indicate mosaic floor tile in showers? please confirm this is intent.

ANSWER 1:

- a. The tile is to be sized as specified. We don't see an issue between the tile and room sizes. Finishes have been selected to match another similar recently completed gender neutral project the board completed at another school.
- b. All areas with existing terrazzo that are receiving new Ceramic Tile will need to be chipped down to slab and levelled prior to installation of the new ceramic tile flooring to ensure that no height issue is created between the washrooms with new Floor Tile and hallway space with existing/patched Terrazzo.
- c. No tile cove base is required on walls with a ceramic tile wall being installed. This section of the 093013 Ceramic Tile Specification has been deleted.
- d. There are no Showers in the scope of work so mosaic tiles are not required. This section of the 093013 Ceramic Tile Specification has been deleted.

QUESTION 2: Please provide a specification for the roll down gym divider.

ANSWER 2: The Roll Down Gym Divider is specified in section 11 51 00 Gymnasium Equipment.

QUESTION 3: Who is the base building sprinkler contractor?

ANSWER 3: The DDSB uses Rohen for their annual sprinkler inspection, but the DDSB does not have

a list of prequalified contractors for sprinkler work.

QUESTION 4: Note that Coreflex and Moderco no longer provide gym dividers. Is Forum and

Gym and Health an acceptable alternate?

ANSWER 4: Forum Athletic Products is to be the acceptable supplier. The specification has been

updated to change the list of acceptable suppliers.

QUESTION 5: Do you have a distributor for the Gymnasium partitions, it seems most on the list

do not supply a product anymore.

ANSWER 5: See response to Question 4.

QUESTION 6: Please provide scope of work for asbestos removal.

ANSWER 6: Designated Substances noted in working areas the Limited Designated Substance

Survey included in the specification section 024115 to be abated as part of the contract

prior to commencement of other renovation activities.

If additional designated substances are uncovered when walls and ceilings are demolished those hidden spaces will require review and removal as required. This

additional work will be covered under the project's cash allowance.

QUESTION 7: The Limited Designated Substances Survey indicates that asbestos was found in

several locations on site, and Type 2 abatement has been recommended. Please confirm that Type 2 abatement has been completed or will be completed prior to

the work taking place?

ANSWER 7: See response to Question 6.

QUESTION 8: Please clarify whether the entire abatement scope of work is included the cash

allowance as per Section 02 82 00- Item 1.1.1, or if solely unforeseen abatement

work is included the cash allowance as per Section 01 11 00- Item 1.29.8.3?

ANSWER 8: See response to Question 6.

QUESTION 9: The wall tile CWR 4 x 16- room schedule indicates wall tile all the way to the

floor, however the specifications state a 4 x 12 porcelain tile cove base. The

specified porcelain tile doesn't come with a cove base available.

ANSWER 9: No tile cove base is required on walls with a ceramic tile wall being installed.

QUESTION 10: Since the main lobby is existing terrazzo, is the tile in the washrooms not going

to present a hazard with the height difference?

ANSWER 10: All areas with existing terrazzo that are receiving new Ceramic Tile will need to be

chipped down to slab and levelled prior to installation of the new ceramic tile flooring to ensure that no height issue is created between the washrooms with new Floor Tile and

hallway space with existing/patched Terrazzo.
